**PROVIDING A SCHEDULE TO BE OBSERVED BY TRUCK OPERATORS
FOR THE RELEASE AND PULL OUT OF CARGO FROM THE CEBU
INTERNATIONAL PORT**

WHEREAS, the traffic situation along the Central Nautical Highway that passes thru the Municipality of Consolacion and the Municipality of Liloan has worsened;

WHEREAS, truck and cargo vehicles converge at the Cebu International Port during the release of their cargoes that clog roads leading to the pier area causing a ripple effect on the traffic situation all the way to the Municipality of Consolacion and the Municipality of Liloan;

WHEREAS, there is an urgent need to decongest the Cebu International Port during peak hours to alleviate the heavy traffic volume in affected areas;

WHEREAS, on January 7, 2020, in a meeting where the Mayor of Liloan, the Mayor of Consolacion, the Cebu District Collector of the Bureau of Customs, the Cebu Port Authority, the Regional Director of the Land Transportation Franchising and Regulatory Board, the Regional Director of the Land Transportation Office, and other stakeholders were present, a daily schedule for the pull out of cargo was determined for truck operators to follow in the Cebu International Port;


WHEREAS, Republic Act No. 7160, otherwise known as the *Local Government Code of 1991*, states that provinces shall exercise powers necessary, appropriate, or incidental for its efficient and effective governance and those which are essential to the promotion of general welfare, health, and safety, including the provisions of services to control communicable diseases;

NOW, THEREFORE, I, **GWENDOLYN F. GARCIA**, in consideration of the foregoing premises, hereby order that the releasing and pulling out of cargo from the Cebu International Port shall be from **9:00 PM to 5:00 AM, Mondays to Sundays**, effective **January 15, 2021**.

The truck ban in the Municipality of Consolacion and the Municipality of Liloan shall be from **5:00 AM to 9:00 AM and 5:00 PM to 9:00PM**.

ALLOWING THE PULLOUT OF CARGO FROM THE CEBU INTERNATIONAL PORT INTENDED FOR TRANSFER TO DOMESTIC BASEPORTS AND CONTAINER YARDS LOCATED WITHIN THE PORTZONE.

WHEREAS, on January 12, 2021, Governor Gwendolyn F. Garcia issued Executive Order No. 2 Series of 2021, regulating the release and pull out of cargo from the Cebu International Port (CIP) from 9:00 PM to 5:00 AM, Mondays to Sundays, effective January 15, 2021;

WHEREAS, on January 14, 2021, it was agreed that an exemption will be granted to the pullout of cargo intended for the transfer to domestic base ports and other container yards located within the port zone area of the CIP;

WHEREAS, Republic Act No. 7160, otherwise known as the *Local Government Code of 1991*, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare.;

WHEREAS, under the same law, local government units shall, within their respective territorial jurisdictions, ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants.;

NOW, THEREFORE, I, GWENDOLYN F. GARCIA, in consideration of the foregoing premises, hereby allow the release and pull out of cargo from the Cebu International Port intended for transfer to domestic base ports and other container yards located within the port zone area of the CIP at any time of the day.

REGULATING THE RETURN OF EMPTY INTERMODAL CONTAINERS TO CONTAINER YARDS AND EMPTY CARGO TRUCKS PLYING PORTIONS OF THE NATIONAL HIGHWAY.

WHEREAS, on January 12, 2021, Governor Gwendolyn F. Garcia issued Executive Order No. 2, Series of 2021, regulating the release and pull out of cargo from the Cebu International Port (CIP) from 9:00 PM to 5:00 AM, Mondays to Sundays, effective January 15, 2021;

WHEREAS, on January 15, 2021, Governor Gwendolyn F. Garcia issued Executive Order No. 2 - A, Series of 2021, allowed the release and pull out of cargo from the Cebu International Port intended for transfer to domestic base ports and other container yards located within the port zone area of the CIP at any time of the day;

WHEREAS, seeing the positive impact of the aforementioned regulations on the traffic situation around the CIP and other areas of Cebu, there is a need to further regulate the return of empty intermodal containers to container yards;

WHEREAS, Republic Act No. 7160, otherwise known as the *Local Government Code of 1991*, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare.;

WHEREAS, under the same law, local government units shall, within their respective territorial jurisdictions, ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants.;

NOW, THEREFORE, I, GWENDOLYN F. GARCIA, in view of foregoing premises, and in confluence with Executive Order Nos. 2 and 2 - A, Series of 2021, hereby direct all truck operators to transport empty intermodal containers to container yards within **9:00 PM to 5:00 AM** only. The transport of empty intermodal containers transported outside said time frame shall be prohibited.

Empty trailer trucks - not carrying intermodal containers - shall be prohibited from plying the National Highway beginning from the boundary delineating the City of Mandaue and Canduman all the way through the Municipality of Consolacion until the border in Cotcot, Liloan delineating the Municipality of Liloan and the Municipality of Compostela.

This Executive Order shall take effect on **JANUARY 25, 2021**.
